Kish Island – the Venue

Kish is a 91.5-square-kilometre (35.3 sq mi) resort island in Bandar Lengeh County, Hormozgān Province off the southern coast of Iran in the Persian Gulf. Owing to its free trade zone status, the island is touted as a consumer's paradise, with numerous malls, shopping centres, tourist attractions, and resort hotels. It has an estimated population of slightly more than 40,000 residents and about 1 million visitors annually.

Kish Island is one of the most-visited vacation destinations in Southwest Asia. Tourists from many countries who wish to enter Kish Free Zone, are exempt from having to obtain a visa.

Kish Free Zone has been turned into a gateway to Iran's economy. Kish economy has encompassed a wide range of economic compositions in the country.
